

AFFIDAVIT OF ANTI-PERSONNEL ELECTRONIC RAPE AND SEXUAL ASSAULT AT CENTRAL MIDDLE SCHOOL, QUINCY, MASSACHUSETTS/3/29/2018

COVERT ASSAULT AND RAPE OF JOURNALIST WITH RADIO FREQUENCY ANTI-PERSONNEL WEAPONS AT CENTRAL MIDDLE SCHOOL, QUINCY PUBLIC SCHOOLS, ON MARCH 28, 2018

FBI, DHS, LOCAL LAW ENFORCEMENT, AND EMS, AS WELL AS US DOD AND USAF ARE USING WEAPONIZED RADAR ON THE PUBLIC, UNDER ILLEGITIMATE COVER OF “SURVEILLANCE” AND “COURT-AUTHORIZED FEDERAL INVESTIGATION” WHILE REFUSING TO ACKNOWLEDGE THIS USE

FOR PUBLIC DISTRIBUTION, FOR THE PUBLIC EDIFICATION OF ALL AMERICANS AS TO THE NATURE OF THE POTENTIALLY DEADLY WEAPONS BEING USED COVERTLY ON THE PUBLIC IN PUBLIC PLACES, UNDER COVER OF SECRECY, LIES, DEFAMATION, AND “COURT AUTHORIZATIONS” BY CORRUPT AND CRIMINAL COURTS AND JUDGES

I testify herewith, under oath, that yesterday evening, at approximately 6:15 to 6:50 pm, I, a parent of a child studying at Quincy Middle School, Quincy Public Schools, and a publishing writer and journalist, was subjected to extreme and burning assault in my vaginal and vulva area by the presumed use of radio frequency anti-personnel weapons, currently in use by the FBI, DHS, DOD, and local Law Enforcement under cover of Surveillance, using Anti-Personnel devices, at the Science Fair in the School Gymnasium and in my daughter's ‘Home Room’ at school. How this attack was carried out I can only speculate on, but it seems like the close proximity of parents and children and people passing off as parents, each potentially with cell phone trackers, and also DEWs (Directed Energy Weapons) disguised as cell phones, and backpacks, would permit people in close proximity to assist in GPS tracking and facilitation of assault. Why such assaults are conducted on me is known only to the criminals who perpetrate these crimes against my person. I request an investigation into these and related crimes that are ongoing against me and many others.

DEFAMATION, WRONGFUL TARGETING, ILLEGITIMATE SURVEILLANCE

I further testify that since November 2013, in the city of Quincy, Massachusetts, and in neighboring cities of Braintree, Weymouth, Hingham, Hanover, and Boston, Massachusetts, as well as elsewhere in Massachusetts, I have repeatedly been unlawfully stalked, surveilled, attacked with anti-personnel electromagnetic and acoustic technologies, which are being wrongfully permitted for use by miscreants in the law enforcement community on the streets of Massachusetts and inside private residences and businesses as well as public places by means of Memoranda of Understanding between the Departments of Justice and the Departments of Defense, which I have reported on in the course of my journalistic coverage of this matter. This reportage may be found online. Journalistic reportage on this matter has also been recorded by Wikileaks and by journalist Suzie Dawson, who has reported on the Wikileaks coverage of the use of Directed Energy Weapons by Defense contractors and law enforcement departments. Thousands of Americans like myself are being wrongfully targeted, surveilled, defamed, and subjected to community ostracization as well as being human-trafficked into terminal, non-consensual military neuro-experimentation and weapons-testing contracts. These offenses are sadistic and unconscionable.
