I would appreciate if you could kindly provide your comment if any by close of business today August 2, 2019. I will be publishing the article on August 3.

I was hit quite strongly (in India) with anti-personnel weapons, for over 24 hours, directly on completing the draft of my article and sending it to you; this, I presume, is part of the negative AI-response linked to government-protections and crushing of journalism and dissent worldwide. I will indeed be reporting on this matter as well. It is unconscionable that government bodies of

any kind, in any country, can seek to shore themselves up from any need for accountability while engaging in repressive and fully-inexplicable actions of character assassination and psychiatric arrest under wrongful recourse to the Mental Health Act against outstanding citizens engaged in human rights and anti-corruption work such as Mr. Edward Ellis.

May I remind you and the entire London Borough of Redbridge I am an American journalist, who is clearly being retaliated against; using Stealth Assault Weapons (aka Anti-Personnel Non-Lethal Weapons) to effect this retaliation in no way diminishes from the fact that my right to freedom of speech and expression as a member of the media is being assailed. Does this perhaps explain why no-one in the UK from the larger media outlets is covering this story? Freedom of the press in the UK is clearly dead.
